Kuwait Purpose of Payment Codes

Domestic and cross-border Transactions



This document provides the revised Purpose of Payment (PoP) codes as provided by the Central Bank of Kuwait for all transactions i.e. outward domestic, cross border transactions.

The usage of PoP code will be required for all domestic, cross border transactions initiated to/from HSBC Kuwait accounts. Accordingly, please include a valid PoP code from the below list in appropriate field in your payment instruction to avoid any payment delays/rejections in future.

HSBC will provide any further updates in accordance with instructions from the Central Bank of Kuwait.
